#### UNDERCOVER OPERATIONS: ENHANCE YOUR UC PERSONA

Instructor: Special Agent Kenneth R. Cooper has 16 years of LEO experience, with 8 years at the Klamath Falls Police Department as a detective in Street Crimes, Narcotics, and Major Crimes. He has spent 8 years with ATF, 5 years with the Seattle Violent Gang Task Force, and has conducted numerous undercover operations involving firerarms and narcotics, including 9 months in a UC storefront. His investigations include 3 Federal T-III and 2 State

T-III cases.

Instructor: Special Agent Mike McNall has spent 26 years as an ATF Agent in Portland, Oregon, with 2 years attached to the Portland Police Bureau Gang Unit, and 3 years attached to the Portland Police Bureau Youth Gun Anti violence Task Force (YGAT). He has conducted numerous undercover operations involving firearms and narcotics, with the majority of his career spent conducting 40+ firearm trafficking cases involving multiple defendants and additional crimes associated to gun trafficking.

#### SURVIVING THE FIRST THREE SECONDS

Surviving the first three seconds is a program designed to take the reactionary gap off of the officer and put it back onto the suspect. This is done through a 5 step program that focuses on:

- 1. Identifying armed individuals through body language indicators.
- 2. Identifying armed individuals through clothing indicators.
- 3. Street level interrogation skills.
- 4. Street level lie detection skills.
- 5. Identifying assaultive indicators through body language and verbal indicators.

Instructor: Master Trooper Donald Kirk Hensley has been with the North Carolina State Highway Patrol since November 1994. Trooper Hensley is the primary instructor with the North Carolina Highway Patrol Training Academy for the Basic Law Enforcement Course, specializing in Defensive Tactics, Officer Survival, and Electronic Control Device (Taser). Trooper Hensley, on his own time, did extensive research for the Surviving the First Three Seconds class. This course has been taught across the United States & is now an exclusive course with SAFETAC Training. Trooper Hensley was chosen as the Troop G Trooper of the Year for 2011 and 2007, and was nominated for the North Carolina State Highway Patrol Trooper of the Year for 2011. He was also nominated for the Anti-Defamation League SHIELD Award for 2011.
